## The Social Science Journal Western Social Science Association Editorial Search – Call for Application or Nomination

The Editorial and Publications Committee of the Western Social Science Association is soliciting applications for the next Editor of the Association's official journal, The Social Science Journal.

The Social Science Journal has a rich publication history of over 40 years and is currently published by Elsevier Publishers, with a worldwide distribution both electronically and in paper form. The impact factor of the Journal has grown significantly in recent years.

The Editor's three-year term will begin with the operation of the new editorial office (January 2018). The new editor will be responsible for compiling, editing and promoting Volumes 55-57 (2018-2020). An editor may be reappointed to a second and final term not to exceed three years with the recommendation of the Editorial and Publications Committee and final approval of the Executive Council of the Association. Applicants must be members, or become members, of the WSSA by the time of their application and the chosen editor must continue to be a member during his/her tenure as editor.

The Editor is responsible for managing the peer review process for approximately 550-600 submitted manuscripts per year, representing the breadth of the social sciences. He/She will prepare four issues of the journal (approximately 600 printed pages) annually. The editorial office manages the review process using the online services provided by Elsevier Publishing and has responsibility for copy editing and proofreading in accordance with customary publishing standards. The editor will also work with the editorial board of the Journal, and the Executive Council of the WSSA, to promote the Journal. The editor will nominate to the Executive Council, each year, a rotating list of members (or Associate Editors) to the Editorial Board.

The committee seeks a diverse pool of editorial candidates with distinguished scholarly records, previous editorial experience (e.g. service as journal editor, associate editor, editor of scholarly editions, book review editor, etc.) strong organizational and management skills, and the ability to work and communicate well with others, including scholars in academic and non-academic settings. A familiarity with and commitment to SSJ and WSSA are essential.

The WSSA supports the operations of the editorial office with an annual budget for the hiring of an office assistant and for the travel expenses of the Editor. Travel expenses may be provided for the office assistant to attend and help with the Annual Conference. WSSA encourages applicants to secure additional support from their respective institutions; however, the amount of that support will not be the primary factor in the selection of the new editor. The final decision will be based principally on the strength of the application and the applicant. Support from the host institution may include office space, utilities, the use of computers and other office equipment. If appropriate, WSSA encourages a tuition waiver for the office assistant. Faculty release time, travel funds and other basic expenses are also encouraged. Each year the Editor will submit a budget to WSSA to cover those operating expenses that the host institution does not support.

Individuals interested in applying for the editorship should submit a letter of interest, a curriculum vitae, an approximate budget for operating expenses and a letter of support from their department chair and college dean. Guidance in the preparation of applications will be made available. Additionally, the successful candidate will receive a small stipend in compensation for working during the transition period from the current Editor to the new editor.

#### The Value of Revisiting Findings

It's nearly impossible for me to select a "favorite" article from the SSJ. Like a reluctant parent asked to choose, I guess I would claim that each of them is interesting and impressive in their own way. There are two articles, however, that relate to an interesting issue in social science research and so I will highlight them:

Pierce, J.C., N.P. Lovrich, and W.W.Budd (2016). "Social Capital, institutional performance, and sustainability in Italy's regions: Still evidence of enduring historical effects?" Vol. 53, no. 3.

Bruschke, J. and L. Divine (forthcoming). "Debunking Nixon's radio victory in the 1960 election: Re-analyzing the historical record and considering currently unexamined polling data. [this article is available on the website and should appear in Vol. 54, no. 1.]

The papers share two things: They both touch on widely familiar social science findings, and both revisit previous research and assess its current applicability. In the case of the Pierce et al paper, the authors draw upon the work of Robert Putnam, whose seminal research in the 1990's assessed social capital in Italian cities. Using the actual data collected by Putnam originally, Pierce, Lovrich, and Budd revisit whether the historic levels of social capital in Italy's regions and current levels of social capital are related. Their analysis adds to the considerable work on social capital that has accumulated in the time since Putnam's original work.

In the Bruschke and Divine paper, the authors revisit the widely repeated assertion that television viewers of the Nixon-Kennedy debate found Kennedy to be the winner while those who listened on the radio considered Nixon to be the winner. By comparing the single original poll to other polling data contemporary to the debate, the authors conclude that the widely reported finding was based on a poll skewed by the overrepresentation of Republican voters.

Replication of research is an issue that social science has only begun to address. Many reviewers instinctively recommend rejecting papers that replicate well-known results. In other cases, however, we find that many disciplines are encouraging replication as well as the sharing of datasets in open-access mechanisms to allow fellow scholars to replicate their studies and/or refine their models and analyses themselves. In keeping with the direction of most social science publications, Elsevier and the SSJ can now support online linkages to data sets and other auxiliary materials to make the research process more transparent, and replicable. As an Editor, I have no hard and fast rules about replication, but appreciate the importance of revisiting results and casting the clear eye of new methods on long standing findings. I think you'll find the two articles I highlighted above good examples of that kind of replication and revisiting. 

#### Thomas Edison Innovation Fellowship Center for the Protection of Intellectual Property (CPIP) at George Mason University School of Law

**Dr. Kristina Lybecker**, Associate Professor of Business and Economics at Colorado College, was recently offered, and accepted, a 2016-2017 Thomas Edison Innovation Fellowship. Dr. Lybecker served as a member of the WSSA Executive Board for the 2013-2015 term and as Vice-President/Secretary of the WSSA Executive Council for the 2015-2016 year.

CPIP's Thomas Edison Innovation Fellowship Program is a non-resident fellowship program for patent scholars. The Fellowship consists of four invitation-only meetings in which 10-12 Edison Fellows will work closely with four to five distinguished senior patent scholars (Distinguished Senior Commentators) in developing research papers on patent law.

The Edison Fellowship is one of the centerpieces of CPIP's programs in balancing the academic discussion about intellectual property by providing a forum for rigorous, data-driven, high-quality scholarship. Past Edison Fellowship programs have been extremely successful with Distinguished Senior Commentators like FTC Commissioner Joshua Wright, Professor John Duffy (UVA), Professor Jay Kesan (Illinois), Professor Henry Smith (Harvard), Professor Zorina Khan (Bowdoin), and Professor Eric Claeys (Mason).

At the meetings, Edison Fellows work on developing a particular research project. They engage in roundtable discussions, hear presentations by expert scholars, inventors, and industry representatives, and, as the program progresses, Edison Fellows share and collaborate on their own research and drafts.

Each Fellow receives a \$3000 research stipend for producing research on patent law. The stipend will be paid on delivery of the final draft paper that is posted to SSRN and submitted for publication to an academic journal.

Edison Fellows are also encouraged to present their research at conferences or workshops outside of the four Edison meetings. The purpose of the program is for the Edison Fellows to produce rigorous, high-quality scholarship, and this includes presenting it and receiving feedback on it from the broader academic community as well.
