
## It's Conference Season for the WSSA!

President of the Rocky Mountain Council on Latin American Studies. Peach will succeed **Lisa A. Nelson**, who will automatically move up to **President**, replacing Diane Calloway-Graham.

**Doreen Barrie**, Adjunct Assistant Professor in Political

Science at the University of Calgary in Canada was elected WSSA **Vice-President**, edging out Phadrea Ponds of the U.S. Geological Survey in Fort Collins, Colorado.

Doreen has attended WSSA meetings for over a decade and has been involved in the Canadian Studies Section. She is currently a member of the WSSA Executive Council and as the only Canadian on the Council, she has been attempting to generate more interest in the WSSA among her compatriots. Doreen's research interests revolve around water, an extension of previous work on environmental protection in Canada and Australia. She has served on the Board of Advisory Editors of *Great Plains Quarterly*. Doreen is involved in her community, taking the most pride in an institute she co-founded a decade ago. It holds a community conference annually to address complex issues like globalization, biotechnology and water.

Six candidates competed for three openings on the WSSA **Executive Council**. Among the newly elected council members is **Dennis Catlin**, at Northern Arizona University in Tucson. Dennis has attended every conference since his appointment to NAU's Criminal Justice faculty in 1999, and he considers the WSSA his primary source of professional and academic development. Dennis is a leader in the area of Distance Education and continues to develop new methodologies for web delivered courses. For the last three years, he has served as the Section Coordinator for the Criminal Justice and Criminology Section and has regularly

presented papers at WSSA conferences. Dennis has served as Regional Director, Secretary, Vice-President and President of the National Association of State Judicial Educators.

Also elected to the Council was **Steve Pavlik**, who teaches social studies and science at Vision Charter High School for Native American students in Tucson, Arizona. Steve has

been an active member of the Western Social Science Association since 1984 and has three times served as co-chair for the American Indian Studies Section at WSSA conferences. He has edited a collection of papers and has published over forty articles on American Indian education, religion, and ethnozoology. He is active with the Centre for Indian Scholars in Vancouver, British Columbia, Canada, and served as the coordinator for the Second Robert K. Thomas Symposium sponsored by that organization.

**Gene H. Starbuck**, Professor of Sociology and Chair of the Social and Behavioral Sciences Department at Mesa State College in Grand Junction, Colorado, is the third new member of the

Executive Council. Gene has been a member of

WSSA since the late 1970s, and has presented papers the last several years. He was honored with the Outstanding Section Coordinator award for the past two years that he has been the Sociology Section Coordinator, and he continues in that capacity. His recent publications include *Families in Context*, a textbook by Wadsworth. The past two years has found him serving as the Self-Study Coordinator for Mesa State's continued accreditation from The Higher Learning Commission of the North Central Association.

WSSA would like to thank the other nominees, who although not elected, expressed their gratitude for being nominated. Their support of WSSA is much-appreciated.




## Oliver to Deliver Plenary Address

Dr. Melvin Oliver, a foremost expert on race relations in the United States, will address WSSA conference attendees at the Plenary Luncheon, slated for April 22nd. The sociologist, recent Vice-President of the Ford Foundation, and incoming Dean of Social Sciences at the University of California at Santa Barbara, is co-author, with Thomas Shapiro, of the highly influential book *Black Wealth/White Wealth: A New Perspective on Racial Inequality*. In 1996, the book won the C. Wright Mills Award from the Society for the Study of Social Problems, and the Outstanding Book Award on the subject of human rights from the Gustavus Myers Center. In 1997, it received the American Sociological Association's Distinguished Scholarly Publications Award.

Most recently, Dr. Oliver contributed to the production of "Race, the Power of an Illusion", a three-part series that aired on PBS that challenges many beliefs and understandings about race.

Second, we will be having a Past-President Reception for all of our past presidents in the Association. Having this reception is a lead-up for planning our 50th anniversary conference, as we bring together various leadership from over the years. It is an informal opportunity to learn, gain wisdom, and gather information about our past and our future. We will all be together in Salt Lake City soon and I hope you will plan on attending the various receptions at the conference.

## ***INSIDE THE WSSA: A/V EQUIPMENT COSTS***

This is one of a continuing series of articles that attempts to provide our members with a behind the scene view of WSSA. One of the biggest costs at the WSSA or any other conference is for the rental of A/V equipment. Over the years, WSSA has endeavored to provide most of the A/V equipment needed for our presenters. The cost of the equipment can vary considerably from one site to another, i.e. about \$15,000 in Oakland to about \$9,000 in Las Vegas. The rental cost for an overhead projector in Salt Lake City will be \$28.00 and the screen rents for \$25.00. If you consider that we generally have 25 concurrent breakout sessions over three days, the cost of just the overhead projectors will come to about \$3,975 not including tax. Add to this the cost of other commonly used equipment such as video monitors (\$195.00 per use), VHS (\$100.00 per day), slide projectors (\$50.00 per day), and tape players (\$35.00 per day), and the overall cost increases significantly. The last piece of equipment for which we receive requests is LCD Projectors (commonly referred to as PowerPoint). It is clear that LCD Projectors will one day replace the overhead; however, the current rental cost makes it highly prohibitive for the WSSA to support the use of them at this time. The rental cost in Salt Lake City is \$450.00 for the use of the projector and up to \$3,500.00

for the rental of some of the special lenses that would be needed for the larger breakout rooms. At the present time, the projected cost of renting LCD projectors for the conference ranges from a low of \$12,000 to a high of \$30,000 in addition to other equipment that we rent. To cover the additional cost we would have to increase the conference fee by \$17.00 to \$42.00. This is not something that the Executive Council would be in favor of and certainly the attendees would not be thrilled with the type of increase. We hope information such as this, and the cost of catering and guestroom articles, prove to be a help to the members. If you questions, please let us know. This is your Association, we are just the elected and appointed caretakers.

# Welcome to Salt Lake City (Part 2)!

**W**elcome to Salt Lake City, the greatest metropolitan outdoor destination in the West. Salt Lake combines the accessibility and sophistication of a major metropolitan area with the scenic beauty and recreational opportunities of a mountain resort.

In this issue, I will be highlighting dining and nightlife, shopping, and transportation. There are many opportunities for fine dining and nightlife, shopping, and transportation. Here are some of the highlights for dining and nightlife:

**Olio Ristorante:** Located right in the Sheraton City Centre Hotel. It serves pleasingly simple Italian fare.

**First Press Club:** Located in the Sheraton City Centre Hotel. Provides jazz music.

**Market Street Grill:** Located within walking distance of the Sheraton at 48 W. Market St. The phone number is 801-322-4668. This lively restaurant serves only the freshest fare. For breakfast, lunch or dinner, this is probably the most popular seafood restaurant in town. Fresh fish and other deep-sea delicacies are flown in fresh each day from around the country. The place has a classic look.

**Port O' Call Social Club:** Located at 400 S. West Temple in close proximity to the Sheraton. It is one of the biggest, baddest, most hoppin' clubs in town. It has three levels of pinball, pool tables, occasional live entertainment, interactive trivia games and televisions at every turn, there are plenty of things to keep you entertained. They serve chili verde, nachos, burritos and burgers.

**P.F. Chang's China Bistro:** A swank downtown bistro with traditional Chinese food with a modern twist. They are located within walking distance of the Sheraton at 174 W. 300 S. The phone number is 801-539-0500.

**Club Piastra:** Downtown business types and foreign travelers come to this centrally located bar for a drink and contemporary Italian cuisine. One-night memberships are available. They are located in the Marriott Hotel at 220 S. State St. The phone number is 801-961-8700.

**Shaggy's:** The crowd here is mostly the hipster and post-college set. People show up just to see the tacky furniture, and stay for the inviting atmosphere, fun crowd and comfortable seating. Located at 200 S. 150 W., its number is 801-359-2215.

**The Loin House:** Constructed in 1855 as a residence for Brigham Young and his family. There are no tours, but The Pantry Restaurant on the lower level is open to the public.

Here is some information on transportation from the airport and getting around Salt Lake City:

**Sheraton City Centre Hotel:** They have free transportation to and from the airport. Pick up your luggage and then go to any of the complimentary phones around the airport. Contact the Sheraton, and they will tell you an approximate pick up time and where to meet.

**Utah Transit Authority:** UTA operates both the area bus system and TRAX, the city's light-rail system. Most visitors will find TRAX more useful than the buses. The north-south TRAX

line runs between the Delta Center and 10000 South Sandy; the east-west line runs between downtown and the University of Utah. TRAX trains operate Monday thru Saturday roughly 5:30 a.m. to 11 p.m. at 15-minute intervals during daylight and at 30-minute intervals after dark. Buses generally run Monday thru Friday 8 a.m. to midnight with limited service on Saturday. The fare for both trains and buses is US \$1.25 with free transfers allowed between trains and buses. There's a "fare-free

zone" for buses within the downtown area including on the north-south line between the Delta Center and the Courthouse Station at 450 South. Phone: 801-287-4636.

**Rental Cars:** Dollar Rent a Car, 801-575-2580; Advantage Rent a Car, 801-531-1199; Alamo Rent a Car, 801-575-2211; Avis Rent a Car, 801-575-2847; Hertz, 801-575-3495.

Some of the best shopping is located at the following places and TRAX is the best way to access these places:

**Gateway:** An outdoor shopping mall located at 450 W. 100 S.

**Trolley Square:** Indoor shopping mall. It also has many fine dining establishments. It is located at 700 E. 600 S.

**Crossroads Plaza:** An indoor shopping mall, where Nordstrom is located (my personal choice for shopping). It is located at 50 South Main.

**ZCMI Center Mall:** An indoor shopping mall located directly across the street from Crossroads Plaza.

I hope this information is helpful as you plan your conference trip to Salt Lake City. See you in Salt Lake!

## The Verdict: Calgary in '07, Denver in '08

At last April's conference, a survey was circulated asking attendees to pick from a list of potential sites which ones they favored for 2007 and 2008. The clear choices were Denver (Downtown) and Calgary. Since the April meeting we have secured a contract with the Hyatt Regency in Calgary for the April 2007 meeting. This will be the first time that we will be crossing an international boundary for the conference. While this might be a bit risky, it was felt that with the very large representation in Canadian Studies and other affiliates that the risk was worth taking. We also have a great deal of support from the Canadian Government. I have visited the hotel and the surrounding area. To say the least, it is a great hotel and downtown Calgary is a great location for attendees to spend some of their down time while at the conference.

We decided to hold the 2008 conference in Denver. This will be the 50th anniversary of the Association; thus, it seemed appropriate to have the conference located geographically close to its roots. We are currently working with three hotels in the downtown area to determine which will best suit our needs. The three are the Adams Mark, the Hyatt and the Marriott. All of them are great facilities with many positive attributes. I expect that the final decision will be a difficult one.
